

From National Archives Civil War Pension records, Box 33,824, Pension Certificate 169,485.

This was a preprinted form. The only handwritten portions are the names of William and Eliza and the signature of the judge. It is dated 28 July 1854.

William Pumplin and Elizabeth Pumplin were married in Germany. They traveled on the ship Sir Robert Peel as a married couple, and they had a child when they emigrated. Shortly after they arrived in the United States, they apparently were married again in Davenport. This may be because they had no proof of their marriage in Germany. This is the license that was issued for the marriage in Davenport. The license was apparently never filed following the ceremony, according to other documents in the pension file.

Some of the problems may be because the year of the marriage in Davenport was stated as 1853, rather than 1854, in the pension documents.

In this document, dated 28 October 1863, Elizabeth makes what appears to be the first claim for a widow's pension. This document is the only one that mentions William and Elizabeth's oldest son Henry, who was born in Germany. It also is interesting that the Civil War, which was known as the War of Rebellion in the North following the war, is called the "war of 1861."

One of the witnesses, Enoch Quimby, was one of the first settlers in Diamond Bluff, Pierce County. He settled there, according to a local history found on www.rootsweb.net/~wipierce, between 1850 and 1854. The judge, William Hawes, also was one of the first settlers in Pierce County.

This document states that William was born in September 1855. Most of the other documents in the pension file state that he was born 14 February 1855. This document also states that Mary was born in 1859. Most other records found for Mary state that she was born in 1860.

Widow's Claim for Pension.

On this *twenty eighth* day of *October* A.D., 1863, personally appeared before *Hon. William Hawes* County judge of *Pierce County* said Court being a Court of Record within and for said county *Elisabeth Pumplin* aged *thirty* years, a resident of *Trenton*, in the county of *Pierce*, and State of *Wisconsin*, who, being first duly sworn according to law, doth, on her oath, make the following declaration, in order to obtain the benefit of the provision made by the act of Congress approved July 14, 1862: That she is the widow of *William L.H. Pumplin*, who was a *Private* in Company A, commanded by *Captain Orrin T. Maxson*, in the *12th* Regiment of *Wisconsin Infantry*, commanded by *Col. George E. Bryant*, in the war of 1861. That her said husband died at *Vicksburg*, in the State

of Miss., on the *fifth* day of *July* A.D. 1863. Said Wm. L.H. Pumplin having died as aforesaid of Disease contracted while in the service of the United States. while in the line of duty in the service of the United States.

She further declares that she was married to the said *William L.H. Pumplin* at *Davenport Iowa*, on the *12th* day of *August* A.D., 1854 by one *Ole Krogin* a clergyman; that her name before her marriage was *Elisabeth Whitford*, and that ever since the death of her said husband, she has remained a widow: as will more fully appear by reference to the proof annexed.

That during the existence of the aforesaid marriage there were born to her and her said husband the following named children, who are now under the age of sixteen years, viz: *Henry Pumplin*, born the *20th* day of *October*, 1850; *William Pumplin* born *September* 1855, *Augustus* born the *13th* day of *March* 1857, *Mary Pumplin* born *April* 29, 1859 all of whom are still living, and reside in *Trenton Pierce County Wisconsin*.

She also declares that she has in no manner been engaged in, or aided or abetted, the Rebellion in the United States.

They further swear that they were acquainted with the said *William L.H. Pumplin*, deceased, in his life-time, and know that he and the said *Elisabeth Pumplin*, lived and cohabited together as man and wife, up to the time when he entered the service, and that they were generally recognized as such by their acquaintances and neighbors, and their marriage was never questioned. That during the continuance of said marriage there were born to them the following named children, all of who are now under the age of sixteen years, viz: *Henry Pumplin*, *William Pumplin*, *Augustus Pumplin* and *Mary Pumplin*.

That since the death of her said husband, the said *Elisabeth Pumplin* has not married, but is still a widow; and that she is the identical person she represents herself to be. All the foregoing statements they make from their own personal knowledge; and they have no interest in the prosecution of this claim.

In this document dated some time between 1865 and 1867 when L.L. Lewis was Clerk of the County Court, Dr. Orrin T. Maxson, the Captain of William's company and a neighbor, swears that William joined the 12th Wisconsin Infantry Regiment Volunteers as an able-bodied man. This document is the only one in which William's name is spelled Wilhelm Pumplunn, with what appears to be an umlaut over the second U. Elizabeth's name is spelled Elisabeth Pumplunn. Maxon would file a similar deposition from Cook County, Illinois in 1867.

Pumplunn, was seized with the malarious fever produced by exposure and overexertion in the line of his duty in the trenches in [sic] during the Seige [sic] of Vicksburg Mississippi, and that he continued to fail under the effects of said fever until he died which occurred on or about the fifth day of July 1863. That this deponent has been a practicing physician and surgeon for more than ten years last ?; that this deponent was well acquainted with the said Wilhelm L.H. Pumplunn and the said Elisabeth Pumplunn before to [sic] date of his enlistment, and knows that they cohabited together as man and wife, and that several children were born unto them while so living and cohabiting together, and that the fact of their marriage was never doubted or questioned in the neighborhood where they resided. He further says that he is not interested either directly or indirectly in the prosecution of this, her claim.

"A", 12th Regiment of *Wis* Volunteers, to serve 3 years, or during the war, and mustered into service as a *Private* on the 30th day of *October*, 1861, at *Madison*, in Co. "A" 12th Regiment of *Wis* Volunteers to serve 3 years, or during the war. On the *quarterly return of deceased soldiers 3rd October 1863* of that Regiment, dated *September 30th 1863*, he is reported "*Died at Vicksburg July 6th 1863 of Disease.*" *Nature of disease not stated.*

In this document, dated 14 December 1866, Elizabeth swears that she and William were married in June 1853 in Davenport. This would have been impossible because she and William did not

arrive in New York until July of 1854. The copy of the license that was issued in Davenport is dated 1854. By this time, Henry is 16 and is not eligible for a pension.

In this document dated sometime in 1867, Dr. Orrin Maxson again swore to knowing William and Elizabeth and describes how William died. This document is extremely light and difficult to read.

That during the seige [sic] of the City of Vicksburgh [sic] Mississippi, while the said William Pumplin was lying with his regiment in the trenches, he was attacked with the diarrhea and cough fever [sic], which continued to reduce him the said William Pumplin, until on or about the 5th day of July 1863 when he died from the effects of said disease. He further says that the said William Pumplin, deceased, and Elizabeth Pumplin, his wife, lived and cohabited together as man and wife since 1854, and that during the time they so lived and cohabited together as man and wife they had several children born to them and that their marriage was never questioned in the neighborhood in which they resided. And he further says that he is not interested either directly or indirectly in this claim nor in its prosecution.
